

This Privacy Policy governs the manner in which Popkorn Apps collects, uses, maintains and discloses information collected from users (each, a "User") of the [Popkorn Apps](#) mobile application ("App"). This privacy policy applies to the App and all products and services offered by Popkorn Apps.

Personal identification information

We may collect personal identification information from Users in a variety of ways, including, but not limited to, when Users visit our App, register on the App, subscribe to the newsletter, and in connection with other activities, services, features or resources we make available on our App. Users may be asked for, as appropriate, name, email address, phone number. We will collect personal identification information from Users only if they voluntarily submit such information to us. Users can always refuse to supply personally identification information, except that it may prevent them from engaging in certain App related activities.

Non-personal identification information

We may collect non-personal identification information about Users whenever they interact with our App. Non-personal identification information may include the browser name, the type of computer and technical information about Users means of connection to our App, such as the operating system and the Internet service providers utilized and other similar information.

Web browser cookies

Our App may use "data" to enhance User experience. User's web browser places data on their hard drive for record-keeping purposes and sometimes to track information about them.

How we use collected information

Popkorn Apps may collect and use Users personal information for the following purposes:

- - *To improve customer service*
Information you provide helps us respond to your customer service requests and support needs more efficiently.
- - *To personalize user experience*
We may use information in the aggregate to understand how our Users as a group use the services and resources provided on our App.
- - *To improve our App*
We may use feedback you provide to improve our products and services.
- - *To send periodic emails*
We may use the email address to send User information and updates pertaining to their order. It may also be used to respond to their inquiries, questions, and/or other requests. If User decides to opt-in to our mailing list, they will receive emails that may include company news, updates, related product or service information, etc. If at any time the User would like to unsubscribe from receiving future emails, we include detailed unsubscribe instructions at the bottom of each email.

How we protect your information

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on our App.

Sharing your personal information

We do not sell, trade, or rent Users personal identification information to others. We may share generic

aggregated demographic information not linked to any personal identification information regarding visitors and users with our business partners, trusted affiliates and advertisers for the purposes outlined above.

Third party webApps

Users may find advertising or other content on our App that link to the Apps and services of our partners, suppliers, advertisers, sponsors, licensors and other third parties. We do not control the content or links that appear on these Apps and are not responsible for the practices employed by webApps linked to or from our App. In addition, these Apps or services, including their content and links, may be constantly changing. These Apps and services may have their own privacy policies and customer service policies. Browsing and interaction on any other webApp, including webApps which have a link to our App, is subject to that webApp's own terms and policies.

Changes to this privacy policy

Popkorn Apps has the discretion to update this privacy policy at any time. When we do, we will revise the updated date at the bottom of this page and send you an email. We encourage Users to frequently check this page for any changes to stay informed about how we are helping to protect the personal information we collect. You acknowledge and agree that it is your responsibility to review this privacy policy periodically and become aware of modifications.
